### **Alarm Services Bylaw #008-11**

A \$250 fine may be issued for a false alarm. In addition if in any 24 month period the Emergency Services of the Town of Chestermere attend a property for false alarms, the owner of the property shall be liable to pay services fees for the attendance at the false alarm as follows:

### Traffic Bylaw #004-11

Most offences under the Town's traffic bylaw shall be subject to a \$50 fine. Offences with greater penalties include parking on a sidewalk/pathway, or on a boulevard (\$200), truckers utilizing engine retarder brakes (\$250), truckers driving off of designated truck routes (\$250), and parking in handicap zones without a placard displayed (\$500).

### Vicious Dog Bylaw #2002-202/1

Failure to obtain and keep in force restricted dog license	\$500.00
Failure to maintain in force a public liability insurance	\$1500.00
Failure to confine a restricted or vicious dog on owners premises	\$1000.00
Failure to muzzle or otherwise secure a restricted or vicious dog when off the owners premises	\$1000.00

If restricted or vicious dog attacks/bites a person or animal causing injury	\$1500.00
Permitting a restricted or vicious dog to run at large	\$1000.00
Failure to keep under control of an adult person	\$1000.00

### Vicious Dog Bylaw #2002-202 /1 c ont'd

An owner who commits for the second time any of the offences listed above providing the offence is committed within 6 months of committing the first offence – **double the initial penalty**
