BYLAW #013-18

A Bylaw of the City of Chestermere, in the Province of Alberta, to amend Tax Rate Bylaw 010-18.

**WHEREAS** Section 354(4) and 354(5) of the *Municipal Government Act*, RSA 2000, C. M-26 and amendments thereto provides that a Municipal Council are able to revise the property tax bylaw without Ministerial consent when the tax notices have not been set out to residents;

**AND WHEREAS** Council deems it desirable to amend Bylaw 010-18, being the Tax Rate Bylaw.

**NOW THEREFORE** The Council of the City of Chestermere, duly assembled, enacts as follows:

1. Schedule A of Bylaw 010-18 is replaced by Schedule A of Bylaw 013-18, attached.
2. Schedule B of Bylaw 010-18 is replaced by Schedule B of Bylaw 013-18, attached.
3. This Bylaw comes into full force and takes effect on the date of third and final reading.


