BYLAW #009-18

A Bylaw of the City of Chestermere, in the Province of Alberta, to change the designation of certain lands from Environmental Reserve (ER) to Public Utility Lot (PUL).

WHEREAS the lands hereafter described are wholly owned by the City and are used as stormwater facilities

WHEREAS Section 676(1)(a) of the Municipal Government Act, RSA 2000, C. M-26 and amendments thereto provides that a Municipal Council may by bylaw, after giving notice in accordance with section 606 and holding a public Hearing in accordance with Section 230 change the boundaries of an environmental reserve in order to correct an error in the title;

AND WHEREAS Council deems it desirable to change the legal designation of the following lands from Environmental Reserve (ER) to Public Utility Lot (PUL):

Lot 69ER, Block 5, Plan 0410396; Lot 67ER, Block 5, Plan 0410396; Lot 2ER, Block 6, Plan 0214334; Lot 3ER, Block 6, Plan 0210284; Lot 32ER, Block 4, Plan 0013002; Lot 33ER, Block 4, Plan 0210798; Lot 84ER, Block 4, Plan 0814323; Lot 35ER, Block 2, Plan 0610631; Lot 32ER, Block 17, Plan 0414609; Lot 26ER, Block 17, Plan 0811389; Lot 70ER, Block 1, Plan 0013052; and Lot 67ER, Block 7, Plan 0414054.

NOW THEREFORE, The Council of the City of Chestermere, duly assembled, enacts as follows:

1. That the legal designation of Lot 69ER, Block 5, Plan 0410396; Lot 2ER, Block 6, 0214334; Lot 3ER, Block 6, Plan 0210284; Lot 32ER, Block 4, Plan 0013002; Lot 33ER, Block 4, Plan 0210798; Lot 84ER, Block 4, Plan 0814323; Lot 35ER, Block 2, Plan 0610631; Lot 32ER, Block 17, Plan 0414609; and Lot 26ER, Block 17, Plan 0811389 be changed from Environmental Reserve (ER) to Public Utility Lot (PUL) as shown on attached Schedule "A" attached to and forming part of this Bylaw.
2. This Bylaw comes into full force and takes effect on the date of third and final reading.

READ A SECOND TIME this 22nd day of May, 2018.



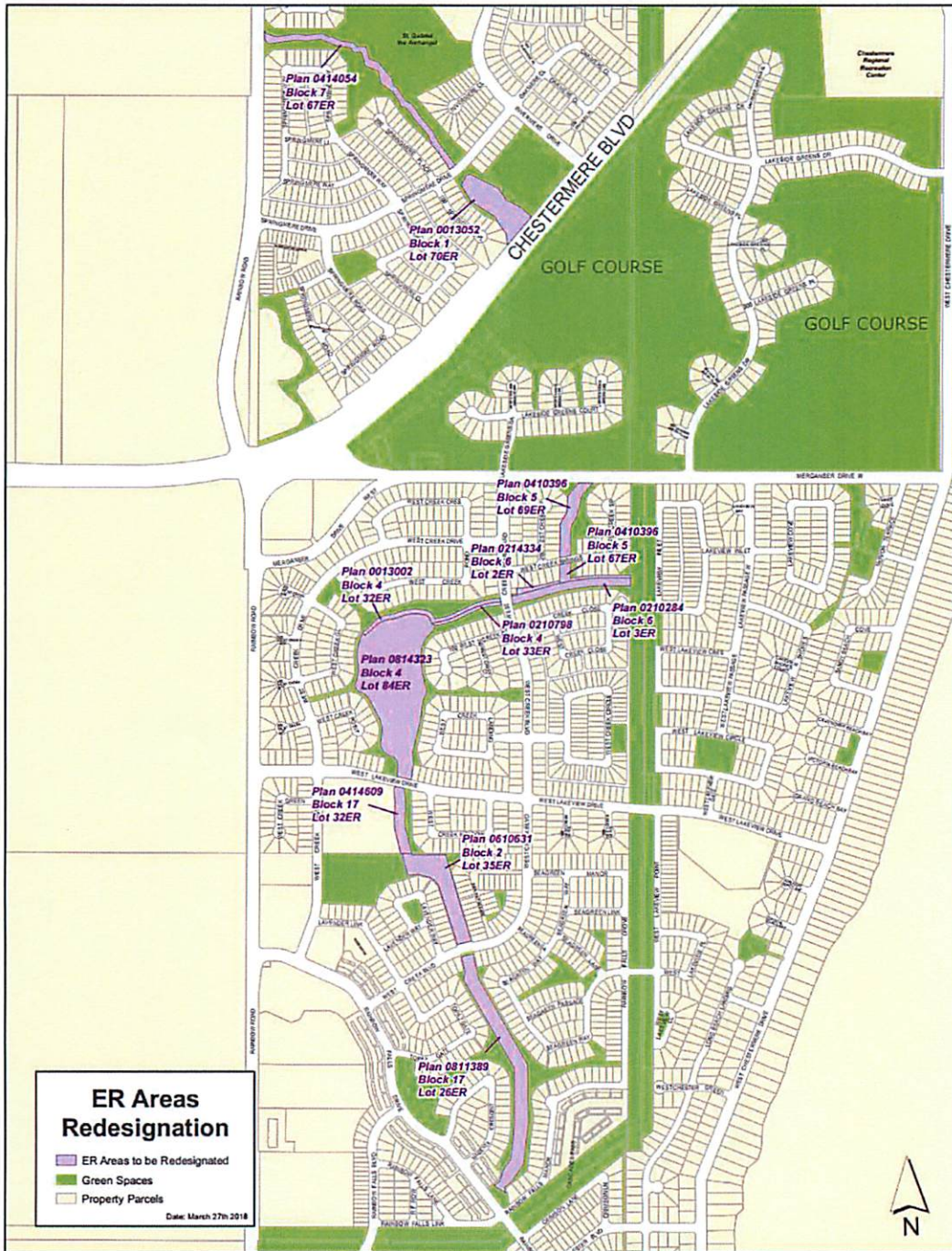
