BYLAW #042-20

A Bylaw of the City of Chestermere, in the Province of Alberta, to amend Bylaw No. 008-15, being the Waste Management Bylaw and repeal Bylaw No. 020-19, being the Waste Management Bylaw amendment.

WHEREAS The Municipal Government Act, RSA 2000, C. M-26 and amendments thereto provides that the purposes of a municipality are to provide services, facilities or other things that, in the opinion council, are necessary or desirable for all or a part of the municipality;

AND WHEREAS Council deems it desirable to amend Bylaw 008-15 and repeal Bylaw No. 020-19.


NOW THEREFORE, The Council of the City of Chestermere, duly assembled, enacts as follows:

1. Bylaw No. 020-19 is repealed.
2. Schedule "B" to Bylaw No. 008-15 is repealed and replaced with Schedule "B" attached hereto.
3. This Bylaw shall take effect and come into force effective January 1, 2021 upon the final reading and signing by the Chief Elected Official and Chief Administrative Officer, or their authorized delegates.

SCHEDULE "B"

RESIDENTIAL RATES, FEES AND CHARGES

The following rates and charges apply to all residential dwelling Customers in the City of Chestermere:

Base Rate	\$23.49 per month per individual dwelling unit
EcoCentre Fee	\$4.17 per month per residential dwelling unit
New Accounts Set-up Fee	\$25.00
Replacement Residential Recycle Collection Cart	\$70.00
Replacement Residential Organic Collection Cart	\$60.00
Replacement Residential Garbage Collection Cart	\$60.00
Additional Kitchen Catcher	\$4.00
Delivery Charge	\$4.00
Excess Residential Organic Materials One (1) Unit	\$7.00 per month per individual dwelling unit with a minimum one year of service
Excess Residential Organic Materials One (1) Unit – Lake Weed content only	\$7.00 per month per individual dwelling unit with a minimum one year of service
Excess Residential Recyclable Materials One (1) Unit	\$7.00 per month per individual dwelling unit with a minimum one year of service
Excess Residential Garbage Materials One (1) Unit	\$7.00 per month per individual dwelling unit with a minimum one year of service

NON-RESIDENT RATES, FEES AND CHARGES

The following rates and charges apply to all non-residents of the City of Chestermere with regards to the Eco Center:

Pick-up Truck – regardless of size of load	\$25.00
Pick-up Truck and trailer– regardless of size of load	\$50.00
Bags of grass clippings – any amount	\$25.00
Tires, Paints & Electronics	
Tires – up to 4 (no commercial sized tires will be accepted)	\$25.00
Additional tires	\$5.00 each
Paints – up to 6 household size containers	\$25.00
Electronics – less the 2 TV's	\$25.00
Electronics – more than 2 TV's	\$50.00
Small appliances – up to 3 microwave size	\$25.00
Additional small appliances	\$10.00 each
Cardboard, Plastics #1 to #7 and Paper Material	
Pickup Truck, Car Trunk, SUV cargo area – any amount (trailers of any size will not be accepted)	\$25.00
